ICS 100: Introduction to the Incident Command System The ICS' development was inter-agency between the governmental agencies of California and Arizona. Originally, ICS addressed the response protocol and command structure during wildfires. Since its development, ICS has been adopted by the National Incident Management System (NIMS). The National Incident Management System plays a key role in all FEMA response events and hazard-situations. Therefore, ICS is the command protocol for any HazMat situation, active shooter response, or other temporary incidents. The ICS command response is designed for flexibility, scalability, and efficiency. It provides the structure to enable seamless managerial shifts and adaptation across any department. It prevents redundancy of efforts and a clear authority hierarchy in an emergency situation. FEMA describes an incident, as ICS is involved, as "unplanned situations necessitating a response". For example, a hostage crisis, wildfires, hazardous material spills, disease outbreaks, terrorist attacks, and search-and-rescue operations adhere to the ICS structure. The ICS describes an "Event" as a situation that was planned for. Such events include concerts, parades, fairs, political appearances, and others.
