### CAPITOLUL I. Organizarea activității în sistemele de plăți cu carduri bancare

#### 1. Prevederi generale

1.1. În temeiul articolelor 5, 11, 44 și 72 din Legea cu privire la Banca Națională a Moldovei nr.548-XIII din 21 iulie 1995 se emite prezentul Regulament, având ca obiect reglementarea activității băncilor licențiate de Banca Națională a Moldovei (în continuare bănci) și a clienților acestora în cadrul sistemelor de plăți cu carduri bancare.

1.2. În sensul prezentului Regulament sunt utilizate următoarele noțiuni:
